

RESIDENCY STEP BY STEP

For those who arrive in Spain, with the intention to reside here permanently and wish to comply with the law and register as residents on the Registro de Extranjeros.

Experiences shared by members, teach us that the procedures and the order in which they are executed, may vary from Town Hall to Town Hall from Foreigners Office to Foreigners Office and probably even from civil servant to civil servant.

This document cannot take into account all these possible variations, but will outline the procedures and most commonly followed order.

- Open a bank account either deposit the legally required amount for Residency (generally accepted 6.000 euros per person, lesser total for family consisting of adults and minors) or start monthly payments (generally accepted 600 euros per person) into the account. As the funds must have been in the bank for at least three months, best take care of this on one of your visits prior to the definite move.
- 2. Once you have moved into your new home register on the Padrón at the Town Hall with your passport or, if you have it with your NIE number.
- 3. Get healthcare sorted as you will have to bring proof of medical insurance with your Residencia application.
 - a. If you have a form that certifies you are entitled to public healthcare from your home country, that is recognized here in Spain (for UK it is the S1) take this to INSS office. In some offices you will get a stamped copy that you can use for Residency Application and/or take directly to the medical centre where

you wish to register, with others you do not and will have to wait for the stamped copy to be returned to you by mail (can take up to 6 weeks) or

b. Take out private insurance.

Note: Although many Foreigners Offices (Estepona amongst them) will accept your EHIC card or equivalent as proof of medical cover it is technically not legal to present this. The EHIC is valid for medical care outside of the country where you reside. This means that the minute you register as resident here in Spain, the EHIC technically is not valid to cover medical costs in Spain, only outside of Spain and you will have to apply for a new card that states your new country of residence. Some Foreigners Offices now even demand you bring a certificate from your insurance company that states you have committed to pay premium for at least a year.

- 4. Check your passport is valid or that you can present proof that the renewal is in progress.
- 5. Get statements from the bank certifying the amount required for Residency has been in place for the previous 3 months, either by a bulk sum, or consecutive monthly transfers.
- 6. Get a Certificado de Empadronamiento from the Town Hall (not required by all Foreigners Offices).
- 7. If you do not have a NIE number prepare other proof of address like a Copia Simple, Escritura or Rental contract.
- 8. Make copies of everything passport both front page and photo page.
- Download Modelo EX18 form from The Library on our website, fill out one for each person applying for Residency (or ask for it at the Foreigners Office and fill it in there).
- 10. Make appointment with Foreigners Office, usually at the Policia Nacional
- 11. Take with you form EX18, all your documents and photocopies etc. Civil Servant will give you another form to take to a bank to pay 'tasa' (there should be a bank close by to pay this) then return this form when paid and either receive Residency Certificate on the spot, or collect next day.
- 12. For the application you have to go in person, collecting can be done by anyone carrying the blue copy of the Modelo 790 (tasa form).

ONCE YOU HAVE THE RESIDENCY CERTIFICATE suggestions;

- 13. If you do not want to carry the original certificate with you, make copies and have them 'compulsado' (certified) at the Policia Nacional, Notary or Town Hall. NOTE Although it is tempting do not laminate the credit card sized certificate as some authorities refuse to acknowledge them if not presented in original state.
- 14. If you did not have a NIE number before registering as resident, you need to update your registration on the Padrón as you will only be able to benefit from discounts on IBI etc. if you are registered with a NIE number. Please note that the offer of discounts varies per town/province/Comunidad, some do not offer any at all.
- 15. Change your non-resident bank account into resident account (fewer charges).
